Parents,

Please be advised that **MIXED MARITIAL ARTS TRAINING IS AN INHERINTLY DANGEROUS ACTIVITY WHICH INVOLVES SUBSTANTIAL RISK OF SERIOUS BODILY INJURY AND/OR HARM!**

Accordingly, in consideration of being allowed to participate in any martial arts, sports or athletic training and/or instruction offered and/or sponsored by Reality Martial Arts, Inc., and any and all related events and activities, and intending to be legally bound, the undersigned do hereby:

1. Acknowledge and fully understand that each participant will be engaging in activities which involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but the actions, inactions or negligence of others and/or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.

2. Assume all of the forgoing risk and accept personal responsibility for the damages following such injury, permanent disability or death on their own behalf and on behalf of the minor participant.

3. Agree that the undersigned will instruct the minor participant that prior to participating in any martial arts, sports or athletic training and/or instruction offered and/or sponsored by Reality Martial Arts, Inc., he or she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her instructor of such condition(s) and refuse to participate.

4. Release, waive, discharge and covenant not to sue Reality Martial Arts, Inc. and/or its respective administrators, directors, agents, shareholders, instructors, and/or other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and/or owners and lessors of premises used to conduct the martial arts, sports or athletic training and/or instruction offered and/or sponsored by Reality Martial Arts, Inc., all of whom are hereinafter referred to as “releases”, from any and all liability to each of the undersigned, his or her heirs and the next of kin for any and all claims, demands, losses or damages on account for injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
